



## Hunting/Trapping/Fishing Policy (registration form attached)

**Note:** Hunting and trapping in the Wildlands has challenges:

- Getting game out: ATVs and other off-road vehicles are not permitted; vehicle access to the Valley road is Friday- Sunday, 8am- Sunset until October 28, 2018
- There are many non-hunting users at all times of year

### Hunting

- Hunting is subject to State laws. State license and GPMCT registration are required. Use attached form to register. Email or stop by the office for signature
- No baiting of any animal (except for trapping purposes, as allowable by State law)
- No permanent tree stands or duck blinds
- No hunting within 100 feet of maintained gravel roads, campsites or parking lots
- No ATV or 4WD access. Walk in only
- You may be asked to report your harvest to GPMCT via annual survey
- Pick up litter and report trash dumps or game violations to Steward or game warden

### Fishing

Fishing is allowed in the Wildlands, subject to State laws

### Trapping

- By State law, all trappers must carry with them appropriate State license AND written permission from GPMCT.
- Trappers are required to notify Trust of location of traps
- Use attached form to register. Email or stop by the office for signature
- No trapping within 100 ft. of roads, woods roads, campsites, hiking trails or parking lots
- You may be asked to report your harvest to GPMCT via annual survey
- No ATV or 4WD access – walk-in only
- No live trapping of any animal without prior permission of GPMCT

***Watch for other users! You are likely to encounter hikers, bikers, equestrians, pets and others using this land.***
